

The email is forwarded to the Examination Committee and the concern is resolved Care is taken at the departmental level to ensure that grievances are few. Teachers are regularly in touch with students through designated online student groups, so as to prod absentee students into submitting their assignments on time. The policy of

the college is to resolve all students' internal assessment grievance related issues within 7 days of learning about the complaint. The current mechanism ensures that students submit assignments regularly. However, re-tests are conducted within 7-15 days for those not attending the regular internal examination due to unavoidable reasons.
